Job Announcement – (2) Watercraft Inspectors

Golden Sands Resource Conservation & Development Council, Inc. (RC&D) is seeking TWO limited-term watercraft inspectors for the summer of 2018. The primary duty of these positions will be inspecting watercraft entering or leaving the water body and offering educational materials to boaters. Each position will be based at the location described below.

Golden Sands RC&D staff will provide training on aquatic invasive species identification. Inspectors are also required to attend a training event at UW-Stevens Point on proper watercraft inspection procedures following the DNR's Clean Boats, Clean Waters (CBCW) program protocols. (Training is on paid time.) Prior experience with these topics is preferred, but not required. Experience with public communication and/or public service preferred, but not required.

Reliable transportation and proof of vehicle insurance is required for these positions. Mileage to training locations will be reimbursed at the federal mileage rate of \$0.545 per mile. Daily transportation to and from the boat landing is not reimbursed.

These positions pay \$8.00-\$11.00/hr (dependent on experience), with a potential end-of-season bonus of \$3.00 per hour worked (for a potential bonus totaling \$750), contingent on hours worked and satisfactory completion of all reporting requirements. Employment will run from approximately May 21st to Labor Day. **Applicants will be required to work most weekends throughout the season, including part of holiday weekends (Memorial Day, 4th of July, Labor Day).**

Position #1: This position will exclusively serve Pearl Lake in Waushara County, working apx 16 hours per week.

Position #2: This position will exclusively serve Silver Lake, working apx 16 hours per week. Silver Lake is located in the Town of Marion, Waushara County.

These positions are funded at apx **16 hours per week for 16 weeks**. One candidate may apply for both positions, for a combined position of apx. 32 hrs per week.
